Adjutant's Report

The Col. D. H. Lee Martz Camp 10 of the Sons of Confederate Veterans held their February 2016 meeting on the 22nd at the Rockingham County Administration Center.

Cmdr. Philip Way called the meeting to order at 7:00 p.m. Chaplain Lloyd Sprinkle gave the invocation. Camp members gave the pledge of allegiance to the American flag and salutes to the Virginia and Confederate flags.

David Cash moved to accept the January adjutant's report as printed in the February newsletter. Motion was seconded and passed.

Adjutant Tim Turner read the treasurer's report summation for February 2016. Robert Pearson moved to accept the treasurer's summation as read. Motion was seconded and passed.

Second Lt. Cmdr. Delaney Hopkins reported that an envelope from an anonymous donor in Winchester was received at the Dayton Museum and it contained an early flag pennant from the D. H. Lee Martz camp. He also displayed a copy of a newspaper article from The Daily News Record dated January 20, 1926 titled *Robert Edward Lee As A National Asset*.

Adjutant Tim Turner reported that on February 18th on behalf of Camp 10 he presented Sue Forbus, widow of compatriot Frank Forbus, his Last Roll Resolution and it was gratefully and emotionally received.

Committee Reports:

Membership: Bill Miller reported that Mr. Steven Layman has been accepted as a member.

Roger Miller stated he will bring prospective member Mr. Armstrong to the March meeting.

Casey Billhimer reported having a neighbor he is talking with that may be interested in membership.

Adjutant Turner reported eight members did not renew last year which is a lot more than usual.

Programs & Publicity: Casey said that he and Dan Goodson are in the process of putting the Confederate Heritage Proclamation together again for this year. The single veteran sponsorship is still \$20. The ad usually is run on April 17th,

Virginia's secession date, which falls on a Sunday this year so the ad will run on Monday the 18th this year.

After discussion led by Cmdr. Way it was decided to meet at 8:00 am on April 25th to put out the small flags at Woodbine Cemetery followed by breakfast at the Village Inn. Return to Woodbine at 6:00 pm for a brief service then the program by Steve at 7:00 pm in the board of supervisor's room.

Will Shirkey moved to give the April speaker a \$100 travel stipend for speaking at the monthly meeting. Motion was seconded and passed.

Ashby Monument: Rod Clark said his leaf blower is fixed so he will go by and blow off the leaves and branches. He reported the Harrisonburg Electric Company had been on site to remove one tree in way of the power line and he was able to persuade them to remove a second dead tree that was a lesser risk but still needed to be removed as it was a definite hazard to the monument.

Headstones Markers and Monuments: Lt. Cmdr. Wayne Orebaugh said ten stones have been ordered for Woodbine Cemetery. Nine of the stones will be engraved and placed and one will be kept for a spare. All other stones have been placed.

Rod Clark reported continuing to investigate the possible location of an unmarked Confederate grave behind the Eagles. A possible engraving for a stone would be:

UNKNOWN CONFEDERATE SOLDIER BURIED JUNE 1862 CARED FOR UNTIL DEATH
BY THE GOOD FAMILY

New Business:

Cmdr. Way lead discussion to schedule a highway cleanup. Saturday March 26th was set as the date with participants meeting at the old Lacey Springs store at 9:00 am.

An SCV standing order declares March 4th Confederate flag day with all compatriots asked to fly a Confederate flag that day.

Chaplain Lloyd Sprinkle announced that the Southern Chaplains Conference will be held in Harrisonburg again this year at the Providence Baptist Church. The conference will be the first weekend in May with the speakers Thursday Evening and all day Friday.

Todd Biller brought the Intelligence Report magazine for anyone desiring to read the article or make a copy.

Will Shirkey spoke on an article in The Barnes Review.

Cmdr. Way read the poem I'm a Good Ole Rebel.

David Cash inquired if there was any change in the license plate status.

Casey Billhimer showed a pair of Turner Ashby's epaulets that he had purchased from a lady in New York. Discussion was held on the rank and the time that he would have worn them

David Cash moved that the meeting be adjourned. Motion was seconded and passed. Chaplain Sprinkle gave a benediction and the meeting was closed.


