The Letcher Brock's Gap Rifles, later Company B, of Turner Ashby's 7th Virginia Cavalry, was regarded as one of the finest companies in that famous regiment and its Captain, John Quincy Winfield, as one of the most competent.

Award-winning Historian and proud Brock's Gap Descendant Stephen Lee Ritchie began a project to annotate Captain Winfield's letters, but discovered an opportunity to create a biographical memorial to over 400 men who served in the Brock's Gap Rifles.

Plans are to place one stone for unknown Confederate soldier buried in the small cemetery off Port Road. *Ashby Monument:* Rod Clark presented a check in the amount of \$105.00 from the Turner Ashby UDC to pay for the mulch that was applied prior to the Turner Ashby memorial service in June. Rod read a letter from Linda Ridder thanking the camp for the work at the monument. Rod will put chips from ground-up limbs on the grass this fall and apply another load of mulch.

Old Business: Commander Way reminded the camp that the annual camp picnic will be held at Grand Caverns picnic grounds on September 3rd at 1:00 p.m. in shelter #1. Meat and drinks will be provided and members are to bring a dish. Camp members are encouraged to bring items for the silent auction. Ed Karnes moved that the camp give Tim Miller \$150.00 to cover picnic expenses. Lloyd Sprinkle seconded the motion and it passed.

New Business: Walter Wilson reported that there was a company in Staunton that would make polo shirts available to the camp with camp name on sleeve and logo on front. Cost will be approximately \$23.00. The color of the shirts would be gray. Mr. Wilson will bring more information to the August meeting.

Commander Way reported that there would be an August meeting even though it would be close to the picnic. He will check with Casey to see if he has a program planned for this meeting. Delaney Hopkins thanked the camp for


