*Heritage, History & Research:* No Report.

*Ashby Monument:* Rod Clark reported the site looks o.k. The wood chips have not been spread yet and will now schedule that task for spring.

*Headstones, Marker & Monuments:* Rod Clark stated he had not heard from Mike Rinker about the stones they were working on but expected them to be ready in the spring.

**Programs & Publicity:** Adjutant Turner reported that Casey Billhimer has secured a speaker for the February meeting.

CW Trust/SVBF: No report.

**UDC:** Cmdr. Way reported on the status of getting the Turner Ashby monument on the National register of historic sites. The first step is having the monument placed on the State register.

*New Business:* Walter Wilson researched fundraising options for the Camp and to have a raffle or any game of chance the Camp must have its own tax ID and ensure all finances are documented correctly. This is addressed in the SCV handbook Chapter 13. Auctions that do not involve chance are acceptable.

Cmdr. Way read a thank you card from 5<sup>th</sup> Brigade Commander Michael Virts for inviting him to speak at Camp 10's meeting and a letter from UDC Chapter 162 President Ms. Linda Ridder who had sent a \$150 check for mulch for the Ashby monument and provided an update on the status of getting the monument on the historic register.

Walter Williams said that Gary Powers Jr. will be speaking Thursday night in Staunton at the Shenandoah Valley Tea Party meeting speaking about his father and the movie about him. Walter also said he was working on a topic for a meeting and is willing to work on topics of a legal nature if there is interest.

Will Shirkey spoke briefly about the parade saying that he had received high fives along the way. He also read an anonymous letter that he had recently received denouncing the Confederate flag he flew at his house and also containing a veiled threat. He also reported that last issue of The Barnes Review contained an excellent article on the cause of the War Between the States.

Robert Weatherholtz moved that the meeting adjourn. Motion seconded by Will Shirkey and passed. Chaplain Sprinkle gave the benediction and the Commander declared the meeting adjourned at 8:26 pm.
